I write in response to Administrative Assistant Barbara Tanski's correspondence of May 28, 2008 and received on May 29, 2008, and initially submitted by Provost Kunel on March 11, 2008 requesting retroactive approval of a Master of Arts and a Master of Music program in Music Education leading to initial/professional teacher certification, approval to delete two graduate programs leading to permanent certification, approval of a Master of Arts and a Master of Music program in Music Education leading to professional teacher certification, and curricular changes to two graduate music programs, by the University of Rochester.


I am pleased to inform you that on the basis of our review, the programs leading to initial/professional certification detailed on the attached list from the Inventory of Registered Programs are registered for teacher education purposes under Subchapter A of the Regulations of the Commissioner of Education (Chapter II of Title 8 of the Official Compilation of Codes, Rules and Regulations of the State of New York,) effective May 1, 2006 until September 1, 2009. After that date, registration will be extended annually until the Department's next review. Also, the requested changes are approved, as detailed on the attached listing.

In addition, the programs detailed on the attached listing from the Inventory of Registered Programs will be deleted effective February 1, 2011. In the event that any students do not complete studies in these curricula by the termination date, it is the institution's responsibility to request an extension of the programs' registration periods, or to make other arrangements for students to complete their studies.
