Please read all information thoroughly. Once signed and submitted, your summer housing contract is binding.

GENERAL INFORMATION

- We will be accepting summer housing and dining contracts starting Monday, April 1, 2024.
- Summer housing officially begins Monday, May 20, 2024, and ends Saturday, August 10, 2024.
- Students can anticipate remaining in their Spring housing assignments until the weekend of May 24.
 - Detailed information regarding moving from Spring housing Assignment to Summer housing Assignment will come out in early May.
 - Students are <u>required</u> to be present the weekend of May 24 to move their belongings from their Spring housing Assignment to their Summer housing Assignment.
- The University is not responsible for your personal property. You should consider obtaining insurance coverage for your personal property.
- The priority Application/Contract deadline for Summer housing is **May 1, 2024.** Applications will be accepted until July 1, 2024.

ELIGIBILITY AND FEES

- Eligibility for Summer Housing is specifically contingent upon your affiliation with the University of Rochester (UR).
 - You must be a current UR undergraduate student or be with a UR department, academic program, or faculty member to be eligible for summer housing.
- Seniors who graduate in May are eligible to remain for summer housing 2024 and will be billed via their student account.
- Students will pay only one rate for summer housing based on either an Air-Conditioned building or Non-Air-Conditioned building.
 - Air-Conditioned buildings are primarily double rooms, and Non-Air-Conditioned buildings will all be single rooms. **Please note:** the Air-Conditioned buildings do not have kitchen access.

LOCATIONS, RATES, AND IMPORTANT DATES

- Summer Housing locations are Genesee Hall, O'Brien Hall, Hoeing, and Lovejoy
- As demand often exceeds availability, students may or may not receive an air-conditioned space, or a single occupancy space.
- Students must plan to move out of their Spring housing assignment into their Summer housing assignment the weekend of May 24.
 - <u>Please note: students are required to be present the weekend of May 24 to move their</u> <u>belongings. You will not be assigned to Summer housing Assignment if you are not able to</u>

move your belongings from your Spring housing Assignment to your Summer housing Assignment.

Summer Housing ends on Saturday, August 10, 2024, at noon.

CANCELLATION AND CONTRACT CHANGES

A student may cancel their contract without penalty **at least 10 days prior to their scheduled start date** by contacting us at <u>summerhousing@reslife.rochester.edu</u>. Failure to give adequate notice of a cancellation will result in a charge of **\$200**.

BRIDGE PERIOD

- The Bridge period in 2024 is from 8/10 8/22.
- This is one charge of **\$500** and students cannot sign up for a partial bridge contract.
- The only students eligible for a Bridge contract are students with a Full Session or B2 contract.
- Students will move to their fall housing during the first week of August. Those students who will not be in residential housing must move out Saturday, August 10, 2024. **Students will go through the conduct process and incur an additional financial charge if their belongings are not moved out on August 10**.

PAYMENT INFORMATION

- Currently enrolled UR students are eligible for summer housing charges to be posted to their UR student bill.
 - Student bill charges will post for the full contract period indicated.
 - You will see this on your June bill.
 - Summer housing charges placed on the term bill must be paid in full by July 10, 2024.
 - Summer housing charges cannot be carried forward into the next academic year's billing cycles.
- Summer RAs (SRA), and Summer Assistant Managers (SAM), ResLife Facilities student workers, Orientation Leaders:
 - If you are hired by one of these groups, check the Summer Work Projects box on the Summer Housing Application/Contract.
 - These programs will submit official lists of eligible students. If you start as a student employee in one of these areas but your status changes, you may be responsible for a portion of the summer housing fees.
