

# TEACH Grant Application Authorization 2022-2023

## University of Rochester Financial Aid Office

The Teacher Education Assistance for College and Higher Education (TEACH) Grant Program provides grants to graduate students who intend to teach. In exchange for the grant, the student agrees to serve as a highly qualified, full-time teacher in a designated high-need subject area\* in an elementary school, secondary school, or educational service agency that serves students from low-income families for a least four complete academic years within eight years after completing (or ceasing enrollment in) the course of study for which the student received the grant. If the student does not satisfy the service obligation, the TEACH Grant will be treated as a Federal Direct Unsubsidized Loan with accrued interest.

It is important to understand that in order to fulfill the TEACH Grant service agreement, the primary responsibility of your teaching position must be in one of the designated high need fields listed below. Many of the Warner degree programs listed are TEACH Grant eligible solely on the special education component. For example, a special education teacher position would fulfill the high need component, however, an elementary teacher position or history teacher position would NOT fulfill the required service agreement in a high need field.
